Dear Parent of a senior,

At CDS, we are preparing students for college and one of the most important aspects of being successful in college is responsibility. **With parental permission**, we are providing the opportunity for seniors to practice responsibility by allowing them to leave campus when they have a study hall and for the lunch break.

Beginning on **Monday August 17th**, seniors will be allowed to go off campus for lunch every day and off campus during study halls.

Conditions for seniors to be eligible for these privileges are:

- be in good academic standing, not be on academic warning or probation and have no outstanding assignments, including meeting all IB benchmarks and completing all IB assignments
- have no major disciplinary infractions this school year
- have no more than 5 tardies within the last 31 calendar days
- have all driving paperwork completed and submitted

**Senior privileges are:**

- Seniors who have a study hall during any block will be allowed to leave campus with the understanding that they must be back and ready for class before the start of their next period that immediately follows the study hall.
- Seniors who have a study hall at the end of the day (last block) are allowed to leave campus and not return.
- Seniors who have a study hall at the beginning of the day (first block) do not need to report to campus until the 2nd block.
- Seniors will be allowed to leave campus for lunch with the understanding that they must be ready to learn and in their classroom for their next block before the bell rings.

These privileges are dependent on teacher approval. Some classes have combined SL and HL classes and are therefore **not** study halls. Students must be in their classroom for the class before the bell rings on these days.

**Any abuse of these privileges will result in the suspension of the privilege immediately. Students who do not meet the listed criteria will not be allowed to arrive late/leave early or go off campus for lunch and will be expected to be on campus from 8:30 am to 3:30 pm, inclusive.**

**Students should submit this completed form to their senior advisor.**

**While off campus, students should maintain all Covid-19 safety measures, such as wearing masks when social distancing is not possible, including while driving with non-family members in cars, conscientious hand washing and sanitizing, and avoiding high-risk venues.**

**All students will be held accountable for all expectations and policies as outlined in the student handbook.**

Finally, if a senior transports other senior classmates, their names and their parents' signatures **must** be on this form.

**Parent Permission, Waiver, and Acknowledgement:** I understand the requirements and conditions for my child to be eligible for the Senior Privileges and give permission for my child to be off-campus as outlined above. By signing this form I indemnify, release and hold Carrollwood Day School harmless from any and all liability in connection with these Senior Privileges.
